Elementary Dean of Students

High School Principal

On Feb. 19 the 10th grade went to a College Fair in Mahnomen at the Tribal College. Mr. Pugh took his students to River Watch. NWEA testing is complete. Teacher In-Service will be March

29th. Mrs. Hoseth attended a Work Based Coordinator Training on March 7th. Music Ensemble were held in Waubun on March 11 and Mr. Ward's Jazz Band was selected as Best of the Day. Choir also received 8 Superior Ratings and 7 Excellent. On April 10th Polaris will conduct a Career Opportunity Day at NCE. Tate Hoseth will represent Region 8 as Triple AAA Winner at the State Boys Basketball Tourney where a state winner will be announced. Upcoming trips include FCCLA, Senior Trip, Spanish Trip and Baseball Trip.

Superintendent's Report

School received a \$480 rebate from Food Services back to our district. Looking for buyers for next year's house that will be built. Teacher's Union has asked to start negotiations. Lake Agassiz has saved our district \$60,000 to \$70,000 in the last year. Supt. Nudell ask for direction from the board for next year's budget, concerning curriculum, CTE program, reductions, etc. Board wants to proceed with CTE programs, and have administration continue with next year's budget planning process. Board would like to consider continuation of all existing programs and limit any reductions to certified teaching staff.

NEW BUSINESS

Summer Rec

Motion by Opsahl second by Douville to pair with Ulen-Hitterdal for summer rec in baseball and softball this summer. This is due to lack of students and the league with NCW, Ada, and Waubun has dissolved. Swimming, hunter safety, weight room and other programs will still be NCE only.

Achievement and Integration Program

Peggie Chisholm addressed the board and informed them of the Achievement and Integration Grant which is focused on the CTE Program for three years. This grant has been submitted for \$20,498.06 of which \$1,500 will be for a summer Robotic Camp in Mahnomen

And \$18,500 for work based learning coordinator- \(\frac{1}{2} \) salary.

Motion by Nelson, second by Kjono to accept and approve this program.

Discussion: None. Approved. Motion carried. Board thanked Peggie for her time working on this for NCE.

Volunteer Coach

Motion by Nelson, second by Stene to approve Wyatt Pugh as a volunteer track coach for this spring and running coach in the fall.

Discussion: None. Approved. Motion carried.

Choir Trip

Motion by Nelson, second by Douville to approve the Choir Trip to Minneapolis on March 31-April 1. They will be seeing "Mamma Mia" at the Chanhassen Dinner Theater. Forty-four students and six chaperones will be going. Profits from their musical and donations will pay for this trip.

Nelson made a motion, second by Douville to move approval of publication for a Public Hearing regarding potential School Closure in accordance with Minnesota Statutes §123B.51 Subd.5. Discussion: None. Approved. Motion carried.

NCE Building Operations

Supt. Nudell recommended to the board the moving of Grades 3-6 plus 1 Special Ed. this fall (2019) to the high school.

Cost savings would be \$85,000, which would be in utilities, maintenance, administration, support staff realignments and reduced staff travel time.

Motion by Sather, second by Stene to move Grades 3-6 and 1 Special Ed classroom to the high school in the fall of 2019.

Discussion: None. All in favor. Motion carried.
